Brazil continues to be at the forefront of the world's offshore production market. With activity expected to increase over the next few years, Local Content will continue to be an important requirement for the country's industry.

WHAT IS LOCAL CONTENT?

Local Content is a Brazilian federal policy, enforced by the National Agency of Petroleum, Natural Gas, and Biofuels (ANP), that requires operators involved in field development in Brazil to engage with Brazilian suppliers for local goods and services on projects related to the exploration and development stages. Governed by ANP Resolution No. 19, this requirement is referred to as "Local Content," and is defined as a percentage of the contractual value to be provided by the Brazilian industry. Owners typically pass this

minimum content requirement down through the supply chain, so all vendors, shipyards and other suppliers are responsible for the Local Content in their scope of supply. There are provisions for fines in case the minimum amount is not achieved.

WHAT IS LOCAL CONTENT CERTIFICATION?

In order to demonstrate compliance with the contractual Local Content requirements set by ANP, certification of the content is necessary. This certification must be conducted by a Local Content Certification entity accredited by ANP.

ABS is one of the first companies in Brazil accredited by ANP to certify Local Content.
